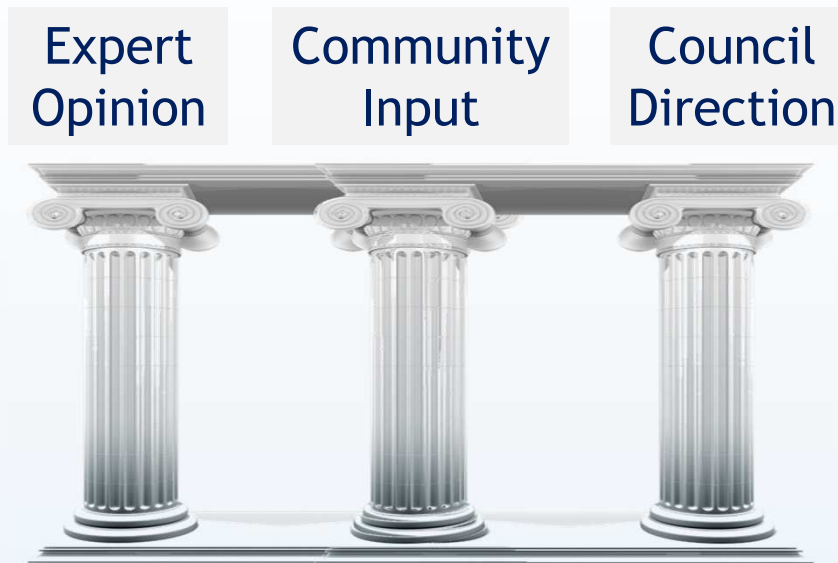

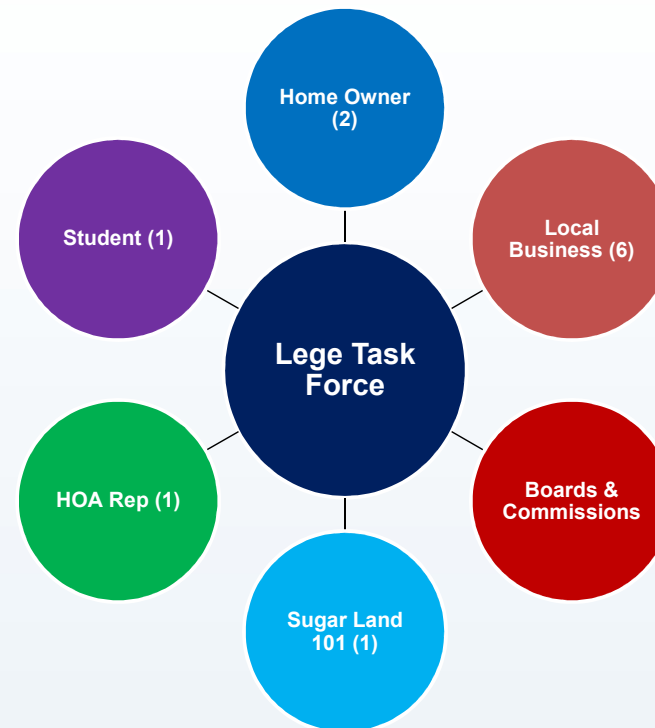

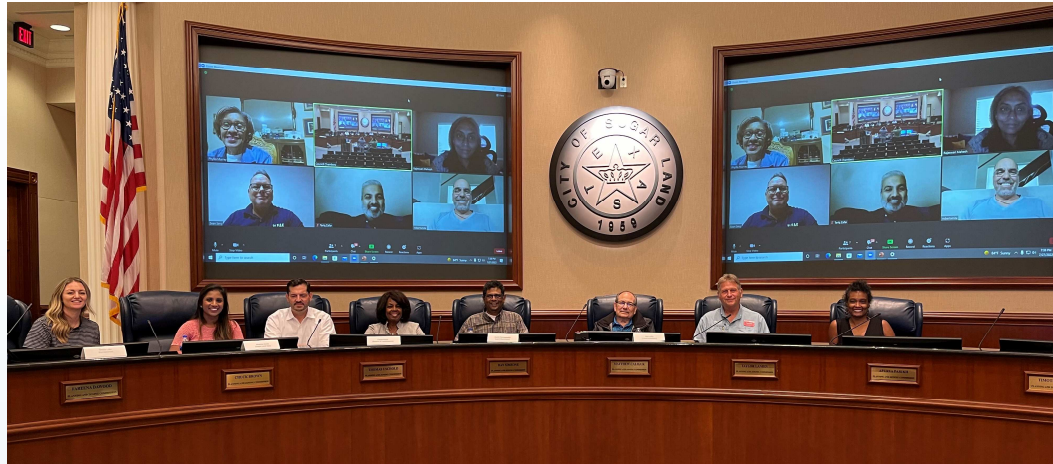
Legislative Citizen Task Force (LTF)

LTF Roles

- Review current agenda
- Provide citizen/business perspective
- Make recommendations
- Grassroots Advocates



Legislative Citizen Task Force (LTF)



- 5 meetings in July-Aug
- Concurred with existing positions
- Offered perspective on new positions

Resolution No. 22-44

- **Meet with legislators prior to the session**
- **Work with partners to pass or defeat legislation**
- **Staff ensures transparency and public engagement**
- **Legislators should understand implications of legislation and seek input of local governments**
- **Legislature should not exempt itself from regulation it would impose on other political subdivisions**

New for the 88th

Active/Mass Shootings

Support increases to state funding for mental health.

Support legislation that provides additional funding to law enforcement agencies to receive increased active shooter training and equipment to protect officers.



New for the 88th

Active/Mass Shootings

Support legislation that provides for all officers who respond to active shooter incidents, including command level officers, to receive active shooter training.

New for the 88th

Active/Mass Shootings

Support expansion of current background check requirements to include review of juvenile records, including checks with state databases and local law enforcement, for the purposes of determining whether the individual has a juvenile record that meets criteria under existing law that disqualifies them from purchasing a firearm.

New for the 88th

Active/Mass Shootings

Support the passage of extreme risk protection order programs that strictly allow for due process and are designed to keep guns out of the hands of criminals, domestic abusers, terrorists (foreign and domestic), or those who intend to harm themselves or others to ensure that threats are identified before shootings occur.

New for the 88th

Catalytic Converter Theft

Support legislation that strengthens current law as it relates to catalytic converter theft and prevention, including increasing penalties for auto repair facilities and individual sellers who resell or are in possession of stolen catalytic converters.



New for the 88th

Solid Waste Franchise Fees

Oppose legislation that would diminish the City's authority to charge solid waste franchise fees, enforce solid waste licenses, or maintain a solid waste franchise agreement.

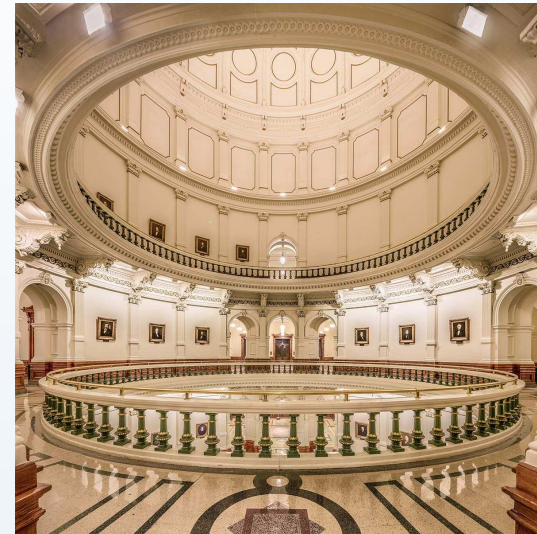
- **Receives input from LTF and experts**

- **At September 20, 2022 meeting, IG Committee finalized the draft agenda and recommended it to be brought before the full City Council**
