Project Background

- 2013 Parks Bond proposition No. 3 included three trail projects:
 - Imperial Connector Trail was completed in 2016
 - Sugar Land Trail (Ditch H Trail) design is currently underway
 - Engineering design for First Colony Trail was completed August 2022

Project Background

- Design scope revised from original 2013 Parks Bond based on stakeholder feedback during public engagement efforts in 2017
- PARCS Board recommended completing project in phases based on available funding in 2019
- City Council concurred with revised scope in 2019
- >Included in voter approved 2020 FBC Parks Bond



Revised Project Scope

- 10' wide trail connections from Lexington Blvd. and Austin Parkway with a bridge spanning Ditch A to the existing Woodstream Trail
- A below-grade crossing under Sweetwater Blvd. and bridge spanning Ditch A
- Two additional bridges, one near First Colony Middle School and at Mesquite Park over Ditch C
- Replace existing sidewalk on Sweetwater between Ditch A and Austin Parkway with 10' wide sidewalk

Budget Amendment

- CIP1702 Sugar Land Trail at 60% design engineers cost estimate \$6M
 - Fort Bend County Park bond package \$3.2M
 - CIP CPK1702 Sugar Land Trail funds \$6.4M
 - Total funding available \$9.6M
- Staff recommends a budget amendment to transfer \$700,000 from CIP CPK1702 Sugar Land Trail to CIP CPK1506 First Colony Trail to cover the budget gap
