Reference is made to that certain Lease Agreement, dated October 28, 2014, as amended by the Consent Agreement and First Amendment to Lease dated December 18, 2018 and the Second Amendment to Lease, dated April 1, 2020, between the City of Sugar Land, Texas and ACE SL, LLC (the "Lease").

In April, we reached out to the City to discuss the possibility of paying debt service reserve payments in advance to allow for reduction in the amount of the letter of credit on file for the Smart Financial Centre at Sugar Land. At the time, the cash balance was \$850,375 and ATG was paying \$33,345.77 per month in additional rent toward the reserve requirement and a letter of credit was on file for \$6,400,000.

After discussing with Jennifer Brown, Director of Fiscal Projects, she advised that ATG could pre-pay the additional rent on the monthly rent payment to bring the cash reserve up to \$1,207,955, which would allow ATG to reduce the letter of credit on file to \$5,200,000. On June 12, 2023, ATG wired payments totaling \$357,579.64 to the City, bringing the Debt Service reserve balance to \$1,207,955.00. A request was sent from HSBC Bank to the City to authorize an amendment to the letter of credit to reduce to \$5,200,000; that request was signed by Jennifer Brown on June 19, 2023.

Beginning with the May 2023 payment due in June through the December payment due in January, ATG will pay \$133,383.23 monthly in base rent. For January & February 2024, the base rent is \$133,399.90. For March 2024, additional rent will begin at \$9,236.75, for a total payment of \$142,636.65. April's rent due in May 2024 will be back to the full payment of \$166,749.87 per month. Please see the table below for the full schedule.
