AMENDMENT NO. 1 TO THE CITY OF SUGAR LAND CONTRACT FOR GENERAL SERVICES (MODIFIED) BETWEEN THE CITY OF SUGAR LAND AND FLOCK GROUP, INC.

This Amendment No. 1 to the City of Sugar Land Contract for General Services (Modified) is entered into among the City of Sugar Land, Texas ("City") and Flock Group, Inc. ("the Company").

Recitals:

WHEREAS, on March 22, 2023, the City entered into a contract with Insight Public Sector for installation of, and a 1 year lease for, an initial 106 Flock license plate recognition ("LPR") cameras (the "Insight Agreement"); and

WHEREAS, on December 22, 2023, the City and Company entered into that City of Sugar Land Contract for General Services (Modified), whereby Company would provide an additional 70 LPR cameras to the City (the "Agreement"); and

WHEREAS, the Agreement included the installation of 70 new LPR cameras, a 5 year lease for existing and new LPR cameras, and a software license for existing and new LPR cameras; and

WHEREAS, the Agreement also terminated the Insight Agreement, to consolidate the existing 106 LPR cameras and 70 new LPR cameras under one agreement with Company; and

WHEREAS, subsequent to the execution of the Agreement, the City and Company have identified cameras that need to be swapped out; and

WHEREAS, the City would like to add an additional 53 LPR cameras to the Agreement; and

WHEREAS, the additional LPR cameras will result in an annual price increase of \$140,750.00 to the Agreement; and

WHEREAS, Section III.G. of the Agreement requires that any amendment be in writing and signed by both parties; and

NOW THEREFORE, the City and Company desire to amend the Agreement to swap out cameras, add additional cameras, and increase the Maximum Contract Amount.

Agreement:

In consideration of the mutual benefits to accrue to each, the Agreement is amended as follows:

1. The Maximum Contract Amount in Section II. of the Contract is changed to \$1,685,980.64 (\$321,230.64/year 1 + \$335,000.00/year 2 + \$343,250.00 in years 3-5).

- 2. That the Company's Amendment to the Agreement documenting the LPR cameras to be swapped out, attached an exhibit hereto, is added to the Agreement as Exhibit A-6.
- 3. That the Company's Amendment to the Agreement documenting the 53 additional LPR cameras to be added to the Agreement, attached as an exhibit hereto, is added to the Agreement as Exhibit A-7.
- 4. This Amendment No. 1 to the City of Sugar Land Contract for General Services (Modified) is effective on the latest of the dates executed by the parties and terminates when the Agreement terminates.
