

**HARVEY-RELATED INTERIOR REPAIRS**  
**SCOPE OF WORK AND BID PRICING FORM**

The Contractor shall furnish all labor, materials, tools, and equipment necessary to perform the tasks outlined in the scope of work.

The Contractor shall clear away all debris and excess materials accumulated at the site and dispose of it away from the premises and maintain neat site conditions. On completion of the project, Contractor shall remove all surplus materials, and leave the site in a broom clean condition.

Contractor shall restore all surfaces disturbed by construction to match with existing finish.

Contractor is responsible for management and implementation of safety and health program for the duration of the project.

Provide on-site supervision while work is being performed.

Damage and repair to existing utilities resulting from the work shall be the responsibility of the contractor.

Finger printing is required for any contractor working at the Police Department.

- Remove and replace 100 sq. ft. of dry wall.
- Remove and dispose of existing carpet (100 sq. ft.).
- Replace 100 sq. ft. of carpet.
- Replace 15 ft. of base cove.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Paint & texture 100 sq. ft. of dry wall; color and texture shall match the existing wall. (paint selection to be pre-approved).

**2. Third Floor – Storage Room 315**

- Remove and replace 100 sq. ft. of dry wall.
- Paint & texture 100 Sq. Ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).

- Remove and replace 64 sq. ft. of dry wall.
- Remove and dispose of existing carpet (64 sq. ft.).
- Replace 64 sq. ft. of Carpet.
- Replace 20 ft. of base cove.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Paint & texture 64 sq. ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).
- Replace fourteen (14) ceiling tiles to match existing tile.

- Paint & texture 60 sq. ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).

**FACILITY 5: PUBLIC WORKS ADMIN, 101A GILLINGHAM LANE****First Floor:**

- Remove and replace 170 sq. ft. of dry wall.
- Remove and dispose of existing carpet (170 sq. ft.).
- Replace 170 sq. ft. of Carpet.

- Replace 19 Ft. of base cove.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Paint & texture 170 sq. ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).
- Replace any damaged insulation if needed.

- Replace threshold on three (3) exterior doors.
- Re-seal 30 ft. of window and frame.

- Remove and replace 400 sq. ft. of dry wall.

- Replace 25 ft. of base cove.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Paint & texture 400 sq. ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).

**FACILITY 8: FIRE STATION #2, 1040 INDUSTRIAL BLVD.**

- Remove and replace 60 sq. ft. of dry wall.
- Remove and dispose of existing carpet (60 sq. ft.).
- Replace 60 sq. ft. of Carpet.
- Replace 10 ft. of base cove.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Paint & texture 60 sq. ft. of dry wall; color and texture shall match the existing wall (paint selection to be pre-approved).
- Replace Nine (9) ceiling tiles to match existing tiles.

**TOTAL FOR FACILITY 8: \$ 3,575.00**

**FACILITY 9: FIRE STATION #7, 1301 CHATHAM AVE.**

- Repair 24" x 24" hole in the ceiling.
- Remove and replace 40 sq. ft. of carpet.
- Carpet color to closely match existing (carpet selection to be approved prior to installation).
- Remove and replace 20 ft. of base cove.
- Remove and repair 25 sq. ft. of ceiling dry wall in the bay.
- Paint & texture 25 sq. ft. of ceiling in the bay. Color and texture shall match the existing wall (paint selection to be pre-approved).
- Reseal window frame in the day room.

**FACILITY 10: ANIMAL SERVICES (CAT BUILDING), 101 GILLINGHAM LANE**

- Remove and replace 6' x 8' plywood floor decking.
- Remove and replace self-adhesive tiles on the 6' x 8 plywood decking (match existing floor tiles).
- Replace 16 ft. of base cove.
- Install floor float.
- Install moisture barrier on the floor decking.
- Remove and replace 6' x 8' textured drywall.
- Paint & texture 6' x 8' drywall. Color and texture shall match the existing wall (paint selection to be pre-approved).
- Remove and replace one (1)-three lamp four footer light fixture.
