### **City's Legislative Program**

- Cities provide local public services (pub safety, drainage, etc.)
- Texas Legislature can greatly impact Texas cities
- Legislative Program aims to protect and enhance the City's ability to deliver priorities of residents, such as:
  - 1. Quality services and programs, and
  - **2.** Health, safety and welfare of the public
- Publically created & adopted by City Council for citizens



## **City Role in Austin**

- **Represent Sugar Land residents**
- File and pass proactive (City led) legislation
- Communicate with legislators, businesses, and sister agencies / organizations
- Actively support or oppose legislation; written and verbal testimony, letters, register positions, etc.
- Monitor legislative process and react accordingly

### **Focused Advocacy**

Legislative Landscape Overview

- Organized Local Gov. opposition and anti-city environment
- Speaker's race extremely important (determines Chairs)
- Facts still matter but not always as "politics" is primary
- Governor and Lt. Governor both extremely committed to lowering the rollback/limiting property tax growth
- Key to success = citizen and business support



### **Focused Advocacy** Prevailing Attitudes

"...on the topic of reining in local government, I am calling for legislation that reduces, restricts and prohibits local regulations." – Gov. Greg Abbott, June 6, 2017 in press conference calling for a special session of the legislature

"As opposed to the state having to take multiple rifle-shot approaches at overriding local regulations, I think a broad-based law by the state of Texas that says across the board, the state is going to pre-empt local regulations, is a superior approach... makes it more simple, more elegant, ...." – Gov. Greg Abbott, March 14, 2017 at Texas **Conservative Coalition Research Institute** 

"Counties, cities ... are creations of the state government. They exist at the sole discretion of the state; receive their responsibilities, powers, and restrictions from the state; and are subject to the direction of the state. Local control is a tool, not a rule...." – Sen. Konni Burton, July 5, 2017 in guest column with Empower Texans





## Speaker's Race is Big Piece of Puzzle

- Current Speaker Joe Straus (R—San Antonio) is retiring
- Candidates announced (thus far):
  - Rep. Phil King (R—Weatherford)
  - Rep. Tan Parker (R—Flower Mound)
  - Rep. John Zerwas (R—Fulshear)
  - Rep. Eric Johnson (D—Dallas)
  - Rep. Travis Clardy (R–East Tx)
- Many candidates are expected to file
- Fight between conservatives and moderates
- Real race begins the day after November election
- Formal election on first day of Session
- Speaker appoints committee chairs and leads negotiations with Lt. Gov. Patrick and Gov. Abbott

- Greater oversight over Municipally Owned Utilities (electric & water) 9.
- Ethics Requirements for City Staff & Elected Officials 10.



### **Focused Advocacy** Gov. Abbott's Property Tax Proposal

- Jan. 16, 2018, Texans for Greg Abbott releases a "Property Tax" **Reform Bicentennial Blueprint**
- 2.5% rollback rate
- Can only be exceeded for certain expenses like "public safety and critical infrastructure"
- Even then, only with a *supermajority* approval at council and at an election
- But can never exceed rate of statewide population growth + inflation

### **Legislative Positions**

- 4 Types of Position Statements
  - Seek Introduction and Passage
  - Support
  - Oppose
  - Monitor
- All positions reviewed today are <u>recommendations</u>



### **Municipal Powers**

- 1. Support local control; allows local officials to make decisions beneficial to interests of City residents
- 2. Oppose preemption; erosion of city authority OR detrimental to City's ability to pursue citizen priorities or respond to citizen concerns

Highlighted items denote priority workshop discussion items.



### **Municipal Revenue & Budgeting**

- 1. Support reduction of overall tax burden on residents & businesses, including:
  - a) Funding public schools
  - **b)** Eliminating unfunded mandates
  - c) Protect municipal revenues
  - d) Homestead & Senior Exemptions



## **Municipal Revenue & Budgeting**

- 1. Support reduction of overall tax burden on residents & businesses, including:
  - e) Collection of internet sales tax
  - Transparent tax rate notification; without confusion
  - **g)** Simple effective tax rate calculation
  - h) Expand use PEG fees
    - Art & cultural program funding



## Municipal Revenue & Budgeting

- 2. Oppose detrimental affects to City finances, budgeting authority, revenue growth for citizen services (i.e. public safety, drainage), including:
  - a) Revenue caps
  - b) Lowering appraisal cap
  - c) Restricting city debt authority
  - d) Unfunded mandates
  - e) City generating funds for State



### **Economic Development**

- 1. Support right to participate in Qualified Hotel Program
- 2. Support Ch. 312 renewal
- **Oppose restriction of Eco Dev tools** 3.
- 4. Support Ch. 380 land swap
- 5. Support eliminating one and adding another sales tax on same ballot initiative
- 6. Support HOT for tourism marketing





### Land-Use and Annexation

- **1.** Oppose legislation diminishing City land-use authority (zoning, building codes, comprehensive planning, annexation, eminent domain, inspection fees, etc.)
- 2. Monitor creation of special districts



## **ROW & Utilities**

- 1. Oppose erosion of authority to manage ROW or receive fair market compensation for use of public ROW
- 2. Oppose limits on using electric utility land for hike/bike trails; increasing of city liability
- 3. Support increased authority to require public notice of major pipeline activities (i.e. flaring)
- **Oppose onerous regulations on utilities provided by city** 4.





### **Transportation, Water Resources**

**Transportation**:

- Support increased state funding for transportation 1.
- 2. Support funding Rail Relocation & Improvement Fund Water Resources:
- Monitor legislation on GCWA, FBSD, BRA, Watermaster 1.
- 2. Support expansion of ability to purchase, provide/use water in City and ETJ, and collaborate with local partners

Support funding for State Water Plan projects



## **Public Safety**

- 1. <u>Seek Introduction and Passage of legislation granting cities</u> the right to be informed by the State about public health incidents within their jurisdictions
- 2. Support local decision making on tech
- 3. Support ability to have more stringent requirements on texting while driving
- **Oppose further reduction city oversight on Home Cottage** 4. **Food facilities**





### Purchasing, Open Meeting/Records

**Purchasing:** 

1. Support alternative project delivery methods

**Open Meetings / Open Records:** 

- 1. Support reduction in financial burden on local governments
- 2. Oppose more restrictive and ambiguous laws and support clarifications that enhance communication
- 3. Support uniform application of laws at all levels of government



## **Transparency/Ethics, Elections**

**Transparency/Ethics:** 

- 1. Support improvements to transparency wo adding legal confusion or duplicating existing disclosure requirements
- **Elections**:
- 1. Support legislation that increases voter participation so long as May uniform date and non-partisan municipal elections are retained







### **Public Advertising, Collective Bargaining**

**Public Advertising:** 

1. Support electronic notice for all public notices

**Collective Bargaining:** 

**1.** Oppose expanding collective bargaining or meet and confer



## TMRS, HOAs

**Texas Municipal Retirement System:** 

- **1.** Support protection of previous and future investments **Homeowners Associations:**
- 1. Support authority and role of HOAs and oppose limitations on HOA functions; no conflicts with City
