Project Background

- The drainage under US90A has been an area of concern for years
- ➤ The Sugar Land Regional Airport experiences flooding of the runway and taxiway during medium to large storm events
- ➤ The southern 2,000 ft. of runway and taxiway flooding affects airport operations during and after these types of events
- Minor events cause runoff to pond at the southeast corner of the runway due to inadequate fall under US 90A


Flooding Events

Project Background

- Airport stormwater discharge is:
 - conveyed through a concrete swale (under Hwy 90A)
 - routed through a TxDOT detention pond
 - connected to a 72-in RCP that outfalls into Bullhead Bayou
- In 2010, TXDOT made Hwy 90A improvements disconnecting the airport from the detention pond



Project Scope

- Reconnect the following:
 - drainage channel to the TxDOT Detention Pond
 - TxDOT Detention Pond to the 72-in RCP

- > Other items include the following elements:
 - Remove/replace existing concrete slope paving
 - Remove/replace storm sewers and manholes
 - Excavate channel and basin
 - Install concrete slope paving, retaining walls, riprap

Contractor Selection

- Design completed in April 2019
- > TXDOT Permit received in November 2019
- > Bids were advertised on April 1 and 8, 2020
- > Bids were opened April 23, 2020
- > Nine (9) bids were received

Budget Amendment Justification

- Budgeted using the design previously reviewed by TXDOT in early 2018
- > TXDOT permitting modifications:
 - Lowering the pilot channel and the connection to the 72-in RCP
 - Adding a manhole, excavation and slope paving
- Modifications increased the cost requiring a budget amendment

- Project is located in a restricted area inside TXDOT Right-of-Way
- > Access from Presidio Court (50-ft. South of Hwy 90A)
- No direct impact to residents

 - Airport staff
 - TXDOT
 - Commercial property adjacent to project site
