EXECUTIVE SUMMARY:

The Fort Bend County Crime Victims Response Team held an event on Saturday, September 4, at Brazos River Park - the First Annual Fort Bend DA Ride for Survivors.

At the January 17, 2006, City Council meeting, the City Council approved an amendment to Chapter Two of the Sugar Land Code of Ordinances. The new amendment provides fee exemptions to eligible nonprofit organizations for meetings and fundraisers as designated in the ordinance.

The Fort Bend County Crime Victims Response Team has requested a fee exemption through the Parks and Recreation Department's Facility Fee Exemption Departmental Policy and Procedure. The criteria for determining an eligible organization for a fundraising event includes:

- 1. Must be an Internal Revenue Service exempt entity, and
- 2. Organization must reside (or have a post office box address) in the corporate city limits of Sugar Land, and
- 3. Must demonstrate that a minimum of 51% of the membership resides in the Sugar Land corporate city limits, and
- 4. Organizations must have a charitable purpose, and
- 5. Must demonstrate that the fundraiser is for the expressed benefit of Sugar Land residents.

The Fort Bend County Crime Victims Response Team submitted their application for fee exemption but were denied for not meeting the above criteria. They are appealing the decision. Per the Policy, an organization that is denied a rental fee exemption may appeal by submitting a request for review, in writing, to the PARCS Board. The Board will review the appeal and make a recommendation to the City Manager.

The appeal letter is attached for the consideration of the PARCS Board. If approved by the PARCS Board and City Manager, the Fort Bend County Crime Victims Response Team will receive a refund of their park rental fees.

Dear Parks and Recreation Policy Advisory Board/ City Manager,

I am writing to appeal your decision to deny the Fort Bend County District Attorney's

Office a rental fee exemption for our upcoming Ride for Survivors fundraiser on September 4th,

2021, and respectfully ask for a policy variance. It is integral to understand the many benefits this

event brings to the residents and community of Fort Bend County.

The Crime Victim's Response Team was created in 2004 with the sole purpose of helping

victims of domestic violence. The organization's goal was to give those victims a network of

support and offer emergency housing and meal services. Domestic Violence shows no favoritism,

and victims are often those of our neighbors, friends, and loved ones. Often, shelters are near or at

capacity, and COVID-19 has added a significant strain to an already burdened system. Through

events such as this, the Crime Victim's Response Team can grant victims emergency housing and

offer one less thing for a domestic violence victim to worry about or have to handle on their own.

I respectfully ask that you reconsider your decision. All proceeds from this event are

allocated to assist victims and their families and go directly to local non-profit domestic violence

service providers. The Ride for Survivors event will help ensure that domestic violence victims in

Fort Bend County are given the necessities needed to recover and heal from the trauma of their

events.
