Lock and tag existing Trane Air Cooled Chiller. Disconnect electrical (high voltage and controls) and chill water piping. Set up crane and remove old chiller and dispose of. Set new Carrier M# 30RBX130 Air Cooled Chiller. Pipe in the new chiller with black pipe sch 40. Have electrician install high j-box and run new high voltage conduit. Pull new wire from j-box to the new chiller. Run new control conduit and wiring. Install two (2) differential switches. Wire in the new control from switches to chiller. Commission BACnet control with building BAS control company. Perform Factory Start up and log chiller.
